## Copyright Release

#### **#1 Copyright Owner Grants Permission to Reproduce Copyrighted Materials**

The undersigned Designer or Architect (the “Copyright Owner”) hereby grants the Builder (as signed below) and HBAFC permission, right and authority to reproduce the Copyrighted Materials, and to publish the Copyrighted Materials in connection with the Parade.

Copyright Owner represents to Builder and HBAFC that the Copyrighted Materials are the result of an original design, that Copyright Owner is the sole owner of and has exclusive rights to the Copyrighted Materials, that such Copyrighted Materials do not violate any copyright, property or common-law rights of others, and that Copyright Owner has the right and authority to grant permission to reproduce and publish the Copyrighted Materials in accordance with this document. Copyright Owner agrees to indemnify and hold harmless from, and defend HBAFC and Builder against, all claims, liability, losses, damages, costs and expenses (including, but not limited to, reasonable attorneys' fees) relating to their use and publication of the Copyrighted Materials for the Parade.
